Occupying over 3500 square feet of office space, the Financial Center features a relaxed, sit-down teller line, a large flat screen television displaying current news, weather and financial market reports, and beautifully appointed private offices for each of its relationship managers and loan officers. Other non-traditional bank services offered at the Folsom Financial Center include Small Business Administration loans, Asset Management & Trust Services and Courier Service for business deposit pick-up.

The Folsom Financial Center staff is lead by a team of financial experts from the local Folsom area.
