Partnership with Mortgagebot LLC enables borrowers to apply 24/7 and receive a loan decision in minutes

Dixon, California - First Northern Community Bancorp (ticker symbol FNRN), holding company for First Northern Bank, today announced the launch of their online mortgage origination website: Choose 'Anytime Loans' at www.thatsmybank.com. The website gives users the ability to research interest rates and loan products, and apply for their mortgage online 24 hours a day, 7 days a week.

Ease and convenience is evident throughout the website. Applicants have the ability to save their application and return to complete it at any time. On weekends, when many lenders are closed, borrowers can investigate products and apply for their mortgage. Eliminating unnecessary questions, the website dynamically changes online questions based on the information entered by the applicant.

Visitors to the site can sign up for Rate Watch where they are emailed rate information. They can select to be notified when a rate hits their desired target or they can choose to receive all the rates for a specific product at certain delivery intervals for a specific duration.

Online tools included in the website consist of mortgage calculators, a glossary, details of what to expect throughout the application process and product descriptions. Help is provided along the application path and is customized for the specific questions that are displayed on the screen.

First Northern Bank, an independent community bank headquartered in Solano County since 1910, serves Solano, Yolo, Sacramento, Placer and the west slope of El Dorado counties. First Northern currently has 11 full service branches located in Dixon, Davis, West Sacramento, Fairfield, Vacaville (2 Branches), Winters, Woodland, Downtown Sacramento, Roseville, and Auburn, and a limited service branch in Folsom.
